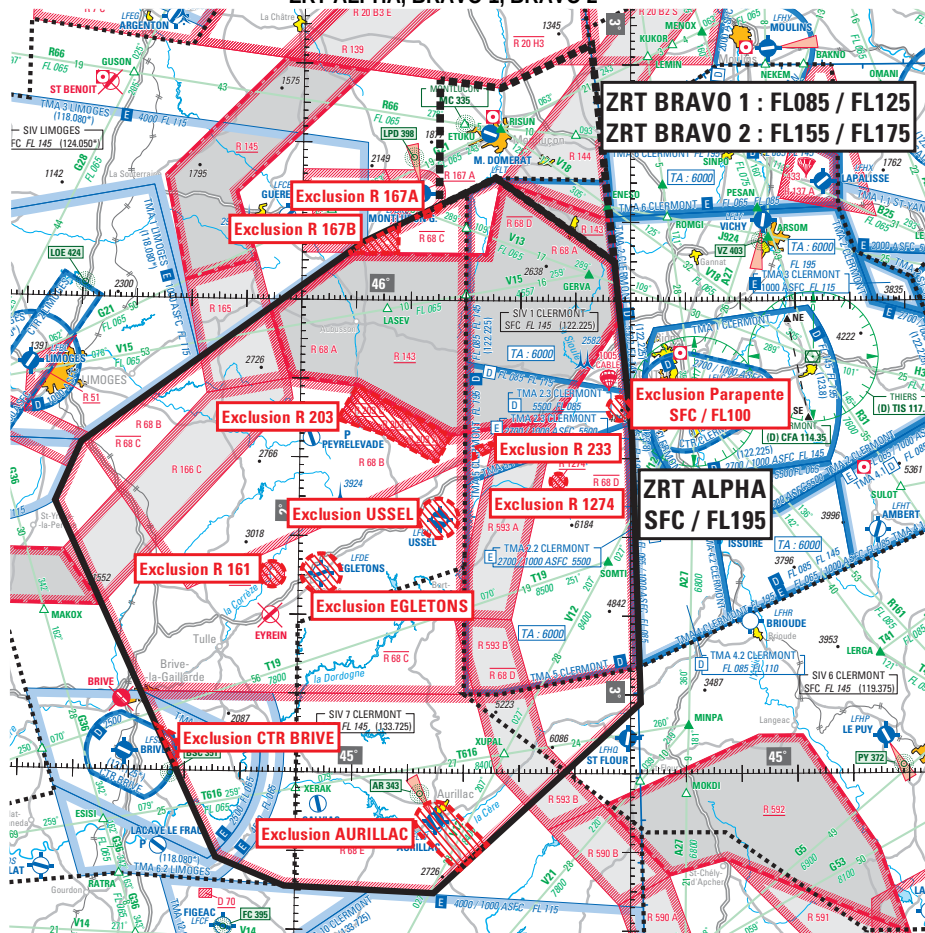

STATUS

Temporary Restricted Areas (ZRT) coexisting with the controlled airspace and replacing the portions of Restricted Areas with which they overlap.

MANAGING AUTHORITIES

ZRT ALPHA and BRAVO 1 and 2 : Lyon Mont Verdun CRC (military Control and Reporting Centre) or Mont-de-Marsan CRC.

ENTRY CONDITIONS

GAT / OAT, compulsory avoidance except for:

- aircraft involved in the exercise,
- aircraft flying under IFR/GAT, guaranteed after coordination with the Lyon Mont Verdun CRC or the Mont-de-Marsan CRC, via the applicable DCC (Civil units of coordination), for inbound and outbound aircraft at BRIVE-SOUILAC (LFSL), MONTLUÇON-GUÉRET (LFBK) and AURILLAC (LFLW),
- aircraft conducting emergency, rescue, customs, police or public safety missions, when the avoidance is not compatible with the performance of these missions; entry is possible upon notification to the Managing Authority.

SERVICES PROVIDED

OAT : control, flight information and alerting are provided within the ZRT by the managing authorities.

GAT : in the portions of ZRT coexisting with controlled airspace, the usual ATC units provide, to the users cleared into the ZRT, Air Traffic services in accordance with the class of this controlled airspace.

LATERAL AND VERTICAL LIMITS

ZRT ALPHA	ZRT BRAVO 1 and 2
<u>Lateral limits</u> Identical to those of Restricted Areas LF-R 68 C, D and E published in AIP FRANCE ENR 5.2, excluding the following Areas : - LF-R 161, LF-R 1274 « BANNE D'ORDANCHE » and LF-R 233 « BOURG LASTIC », which keep their usual status, - LF-R 203 A, B, C « LA COURTIME », when they are active, - overlapping portions of Areas LF-R 167 A and LF-R 167 B «MONTLUCON-GUERET », when they are activated by NOTAM, - overlapping portion of BRIVE SOUILLAC CTR, which keeps its usual status, - AURILLAC, USSEL and EGLETONS aerodrome sectors, - Puy de Dôme paragliding area, 1.5 NM radius circle centred at: 45°46'20"N / 002°57'57"E, from SFC to FL100. <u>Vertical limits</u> SFC / FL195	<u>Lateral limits</u> 46°28'00"N - 002°25'00"E, 46°27'00"N - 002°36'10"E, 46°32'32"N - 002°52'46"E, 46°05'00"N - 002°57'01"E, 46°15'35"N - 002°35'20"E, 46°12'00"N - 002°25'00"E, 46°28'00"N - 002°25'00"E. <u>Vertical limits</u> ZRT BRAVO 1 : FL085 / FL125 ZRT BRAVO 2 : FL155 / FL175

ADDITIONAL PROVISIONS

Upper airspace

Additional activities are scheduled in the following Areas on TUE 19 MAR 2019 :
TSA 43 from 1300 to 1500.

Lower airspace

Restricted Areas LF-R 20 B2 S, LF-R 20 B3 E and LF-R 20 H3 located South of Parallel 46°50'N are reserved for the Exercise on TUE 19 MAR 2019 from 1300 to 1500.

Airfields

GAT/VFR:

- EGLETONS (LFDE) and USSEL (LFCU) :
Activity restricted to aerodrome circling, within a 2.5 NM radius circle centred on the ARP from SFC to 1500FT AGL.
- AURILLAC (LFLW), a sector, from SFC to 1500FT AGL for aerodrome circling and inbound and outbound flights from the South-East :
44°47'33"N 002°29'21"E,
44°52'02"N 002°22'36"E,
Thence clockwise by the arc of a 2.5 NM radius circle centred on 44°53'51.30"N 002°25'00.19"E,
44°55'40"N 002°27'35"E,
