

Subject : Implementation of Flight plan Buffer Zones (FBZ) associated with Danger Areas LF-D 54 DB NORD and LF-D 54 DB SUD (UIR : France - FIR : Marseille LFMM)

With effect : From 22 April 2021 to 09 September 2021

Ref : see AIP SUP 035/21 about the modification of the lateral limits of Danger Areas LF-D 54 DB NORD and LF-D 54 DB SUD.

1 - Description

A FBZ (FPL Buffer Zone) is a volume associated with a TSA, a CBA, a TRA, a Restricted Area or a Danger Area to prevent flight planning within or in the vicinity of a zone during its planned period of activity.

It is designed according to this zone with vertical and / or lateral buffers.

2 - Flight planning

During the zone scheduled hours of activity, a flight plan overlapping with the FBZ volume will automatically be rejected by IFPS. Filing a flight plan via another route will be necessary. These provisions do not apply to aircraft involved in the activities taking place in this zone.

4 - FUA (Flexible Use of Airspace) restrictions and reroutings

FUA restrictions LFD54DBNZR and LFD54DBSZR are published in RAD Appendix 7. "Operational Goal" gives rerouting when FPL is rejected. Each subsequent status modification of ATS routes UZ188, UZ191 and UM154 is notified by NOTAM.
