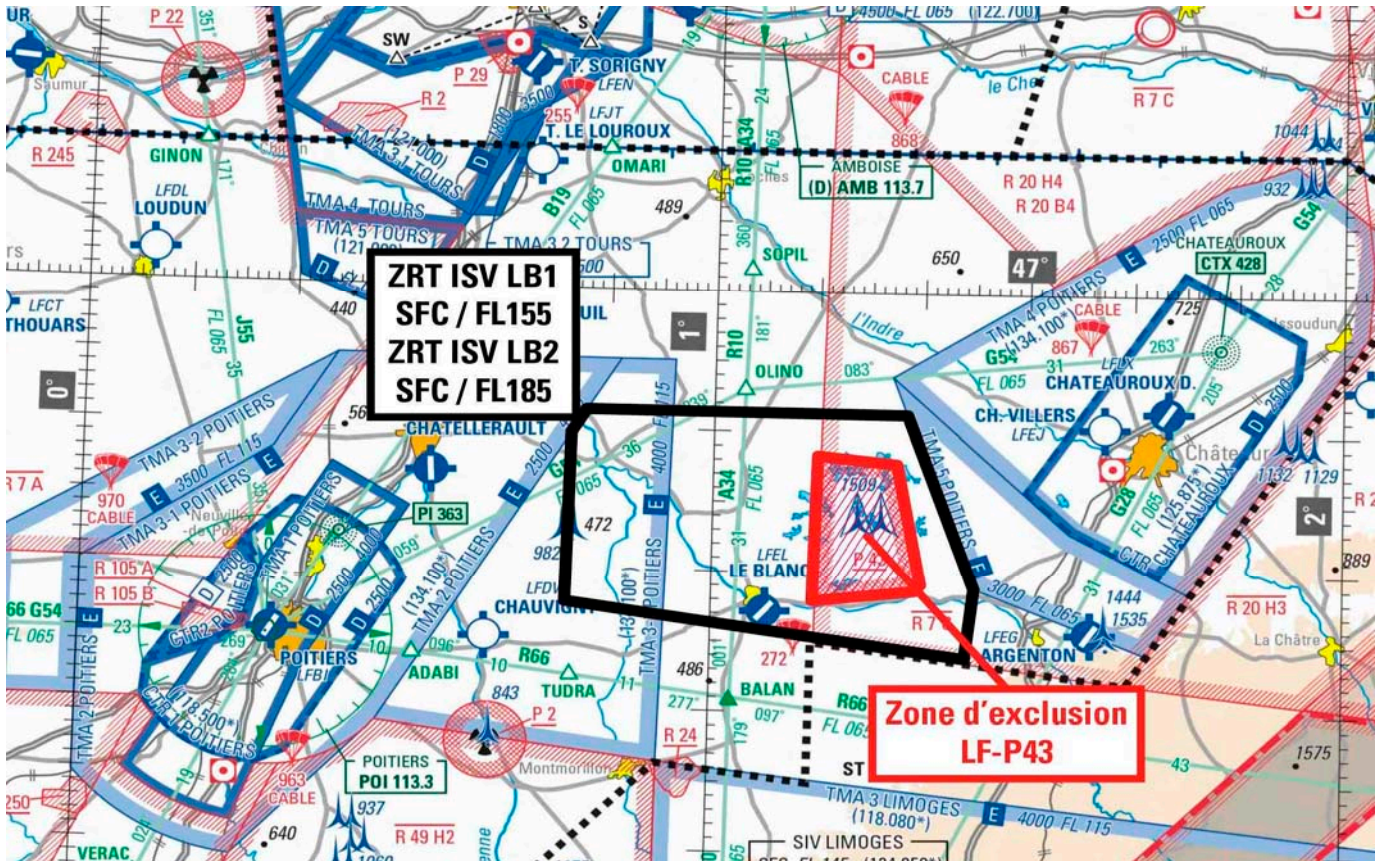


Subject : Creation of two temporary restricted areas (ZRT) as part of under-canopy insertion activities in the Le Blanc region (36)

ACTIVITY

Refresh training of operational parachutists of the French Ministry of the Interior requiring jumps for under-canopy insertion (ISV) exercises.

DATES AND TIMES OF ACTIVITY

ISV LB 1 and LB2 ZRTs can be activated every day from 0700 to 2100

MANAGING AUTHORITY

RAKI (Cinq Mars La Pile CDC)

STATUS

When the ZRTs are active, they replace the portions of airspaces with which they interfere.

ENTRY CONDITIONS

GAT/Military Air Traffic, compulsory avoidance.

VFR GAT: compulsory avoidance except for the following:

AIP SUP No 227/21

- aircraft based at Le Blanc aerodrome and aircraft using Le Blanc hospital center heliport, after obtaining, on the 123.350 MHz frequency, the agreement of the French Ministry of the Interior parachuting unit which will inform the CDC;
- aircraft performing public safety, assistance or rescue missions when these missions are not compatible with area avoidance, after obtaining, on the 123.350 MHz frequency, the agreement of the French Ministry of the Interior parachuting unit which will inform the CDC.

ADDITIONAL PROVISIONS

- The ZRTs cannot be activated when using the interfering areas defined in the AIP SUP No. 086/21 (*Creation of 89 temporary restricted areas (ZRTs) and 3 temporary danger areas (ZDTs) at medium and high altitude, for the transit and flights of State drones to a work area available on the SIA site: www.sia.aviation-civile.gouv.fr*)

When one of the ZRTs is active:

- the following activities can be used in coordination with the French Ministry of the Interior (*which will inform the Cinq Mars La Pile CDC*):

- ◆ Model aircraft flying No. 8317 Le Blanc AD,
- ◆ Towing No. 966-1 Le Blanc AD 1,
- ◆ Glider aerobatics No. 6449 Le Blanc,
- ◆ Parachuting No. 272 Le Blanc AD

ADDITIONAL INFORMATION

- ◆ Every day: activation of **10** one-hour time slots.
- ◆ The LB1 ZRT will be activated for jump time slots at FL145, and LB2 ZRT for those at FL180.
- ◆ Activity forecast available every day from 0600 from the jump activity manager.
