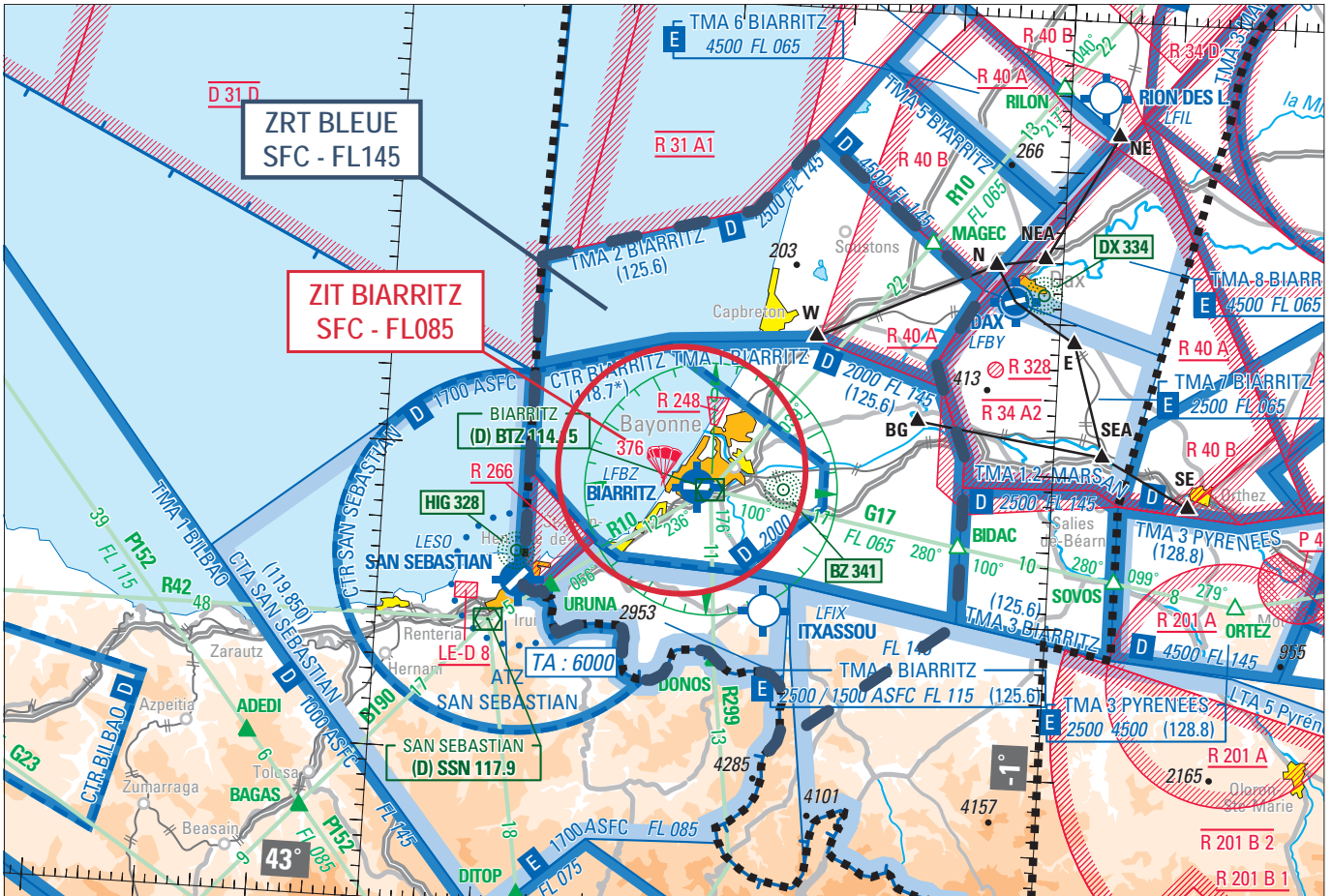


Subject : Creation of a Temporary Prohibited Area (ZIT) and a Temporary Restricted Area (ZRT) over Biarritz for the 2019 G7 Summit aviation security plan

With effect : From 21 to 26 August 2019

Location: FIR: Bordeaux LFBB - AD : Biarritz Bayonne Anglet LFBZ, Itxassou LFIX, Dax Seyresse LFBY



ACTIVITY

Because of the G7 Summit which will take place in Biarritz from 24 to 26 AUG 2019, a Tempo Prohibited Area (ZIT) and a Tempo Restricted Area (ZRT) have been created as part of a special aviation security plan (*"dispositif particulier de sûreté aérienne"* ("DPSA").

STATUS

ZIT BIARRITZ : Tempo Prohibited Area (ZIT) coexisting with the portions of airspace with which it overlaps.
ZRT BLEUE : Tempo Restricted Area (ZRT) coexisting with the controlled airspace with which it overlaps and replacing the portions of Restricted Areas with which it overlaps.

MANAGING AUTHORITY

Mont de Marsan CRC or back-up CRC in case of technical unavailability.

ENTRY CONDITIONS

GAT/OAT : entry prohibited in ZRT BLEUE and ZIT BIARRITZ, except for activities listed in appendix 1; the conditions for these activities are defined in the paragraph « Aviation Security Measures »

SERVICES PROVIDED

OAT : control, flight information and alerting are provided within the ZRT and ZIT by the managing authority.

GAT : in the portions of ZRT coexisting with controlled airspace, the usual ATC units provide, to users cleared into the ZRT, Air Traffic services in accordance with the class of this controlled airspace.

ADDITIONAL PROVISIONS**Prohibited activities within ZRT BLEUE and ZIT BIARRITZ**

Exception for activities listed in appendix 1, all aeronautical activity under GAT/OAT and VFR/IFR is prohibited within ZIT BIARRITZ and ZRT BLEUE, and including the following special activities :

- Model ACFT ;
- Light, leisure and sporting aviation (flying clubs);
- aerobatics ;
- parachuting ;
- Gliding and power gliding ;
- Ultra-light gliders (Para gliders and hand-gliders) ;
- ULM (paramotors included) ;
- Gyroplanes ;
- Aerostat (Free balloons, captive balloons, balloons and sky lanterns) ;
- Airships ;
- Any aerial photography activity including photography taken from a civil drone ;
- Drone activity ;
- Helicopters.

On 21st and 22nd of AUG, IFR Flights bound for Biarritz are authorised to fly into ZIT BIARRITZ and ZRT BLEUE.

The following activities are prohibited outside of ZRT BLEUE :

Parachuting activities No 328 COL DES PALOMBIÈRES and No 364 ST PALAIS are suspended during activation of ZRT BLEUE and ZIT BIARRITZ.

Operations suspended on the following AD:

Aeronautical activity at ITXASSOU AD (LFIX) is suspended during activation of ZRT BLEUE and ZIT BIARRITZ.

Instructions for flights planning

- For IFR flight plans, modification from IFR to VFR is prohibited for the activities authorized as described in the paragraph « Aviation Security Measures »;
- Biarritz AD can not be chosen as an alternate AD.

Additional activities

- Areas TSA 34 C, TSA 34 E, LF-D 31 and LF-R 31 may be activated for Defence.
- The E3-F ACFT will be on orbit area "FR25" located in Tempo Segregated Area TSA 34 and will be controlled by Marengo CMCC.

AVIATION SECURITY MEASURES (1/3)

1. General information

As part of general politic of defence defined by the Government, air defence is permanently involved in homeland security and its airspace through Air Policing. For a special event like the 2019 G7 Summit, Air Policing is reinforced locally and temporarily with the implementation of a "DPSA". This Security plan involves additional detection and intervention means in order to ensure the safety of the event and its participants.

For aviation security reasons, only the activities numbered from 1 to 4, and listed in appendix 1, are authorised in ZIT BIARRITZ and/or ZRT BLEUE.

Specific measures to control air traffic flow which could go as far as temporary flight suspension may be implemented at BIARRITZ BAYONNE ANGLET AD (LFBZ). These measures announced by BIARRITZ APP will be optimally handled by « C2A2 », in order to get back to a normal activity as soon as possible at this AD.

Real time restrictions could be implemented by MIL authorities for security reasons.

ATS procedures : mandatory compliance with the usual operational procedures; however, for aviation security reasons (« DPSA »), restrictions may be implemented in real time at the request of MIL authorities.

Airspace users are invited to consult every day the additional or modification NOTAM that will be published.

2. Authorised activities in ZRT BLEUE and/or ZIT BIARRITZ**2.1. Definitions****2.1.1. Accreditation**

The accreditation is an authorization delivered by « Préfecture des Pyrénées-Atlantiques » once the request made by the applicant has been reviewed, for activities requiring an authorization.

The accreditation does not exempt applicants to get the other authorizations that may be required for their planned activities.

Accreditation procedures and conditions are described in paragraph 3.

2.1.2. Flight plan

Except for activity 1 and emergency missions, flight plan is mandatory with the regulatory deadlines for GAT and OAT flights, whatever the flight rules : VFR or IFR.

For an activity requiring an accreditation, ACFT, pilot and co-pilot's accreditation numbers must be mentioned in box 18 of the flight plan.

2.1.3. Filing a planned activity

Filing a planned activity aims at declaring one's activity before and during the DPSA activation, so this activity will be included in the flight planning. C2A2 is responsible for this flight planning.

The planned activity must filed and arrive to C2A2 at the latest on the day before at 1000 UTC via :

- e-mail : c2a2.g7@gmail.com
- « Officier de coordination » (coordination Manager) C2A2 : to be notified by NOTAM
- "Chef C2A2" : to be notified by NOTAM

The following information about the planned activity must be transmitted to C2A2 :

- 1) Number and type of ACFT ;
- 2) Call sign and registration ;
- 3) Flight date ;
- 4) Departure and destination AD ;
- 5) ETD and ETA ;
- 6) Route and flight altitude ;
- 7) Accreditation number provided (mandatory unless exemption) of ACFT, pilot and co-pilot ;
- 8) type or nature of mission and flight rules ;
- 9) type of ntervention for emergency activities.

AVIATION SECURITY MEASURES (2/3)

2.1.4. Flight intention

During the DPSA activation, flight intention consists in confirming to C2A2 the info that was mentioned when filing the planned activity (paragraph 2.1.3), at the latest 1 HR before take-off, via one of the following means (ranked in order of priority) :

- E-mail : c2a2.g7@gmail.com
- « Officier de coordination » (coordination Manager) C2A2 : to be notified by NOTAM
- Chef C2A2 : to be notified by NOTAM

In return, C2A2 provides an authorisation to fly in ZIT BIARRITZ and/or ZRT BLEUE. This authorisation takes the form of a specific mode 3/A squawk which will identify the flight.

WARNING : authorisation provided by C2A2 to fly in ZIT BIARRITZ and/or ZRT BLEUE (transit, take-off or landing) should never be a substitute for ATC clearances. But this authorisation is required to enter in ZIT BIARRITZ and ZRT BLEUE.

2.3. Transponder

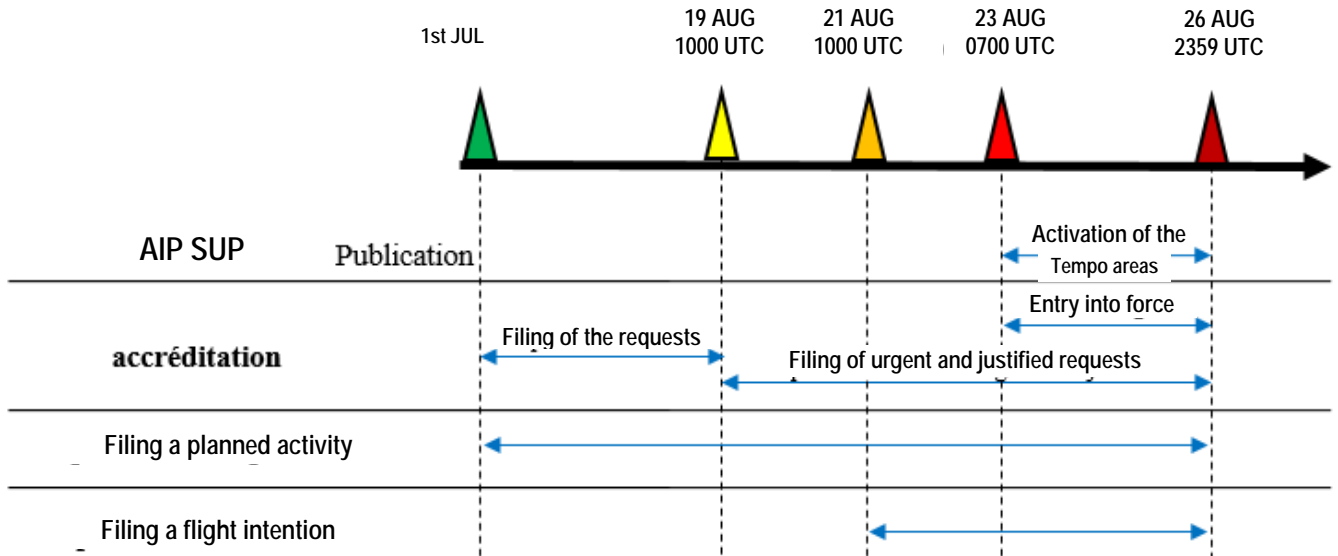
The use of mode 3/A and C transponder is mandatory to fly in ZRT BLEUE and/or ZIT BIARRITZ

3. Accreditations

3.1. Timetable

Accreditations entry into force on FRI 23AUG 2019, 0700UTC (0900 local time) and end on MON 26 AUG 2019, 2359UTC (TUE 27 AUG, 0159 local time).

All accreditation requests and other conditions (filing a planned activity, flight intentions) required to fly in ZIT BIARRITZ and ZRT BLEUE must comply with the following timetable :



AVIATION SECURITY MEASURES (3/3)

3.2. Accreditation request procedure

Accreditation requests are handled by « la Cellule d'Accréditation Interministérielle (CAI) de la préfecture des Pyrénées-Atlantiques ».

These accreditation requests (form in appendix 2) must be filled and sent in electronic format by units, operators or operation centres, with "G7 accreditation request" as e-mail subject, at the following address :

pref-g7-cai@pyrenees-atlantiques.gouv.fr

With this request, all the necessary documents must be attached. Any incomplete request or any request which does not comply with the deadlines shown on the above timetable (except if it is an urgent and justified request) will not be processed by CAI.

Units, operators or operations centres can send their lists of crews and ACFT in addition to the accreditation request.

After processing the requests, CAI will give an accreditation number for the flight. Applicants must make sure they received their accreditation numbers. No answer from CAI does not mean accreditation. The accreditation numbers must be indicated in box 18 of the FPL.

3.3. Urgent accreditation request

Exceptional or urgent request which are justified will be processed by CAI according to its processing capacity, without any accreditation guarantee.

Requests must be sent to the e-mail address mentioned in paragraph 3.2 with the following subject :
